Proposition No. 1

RESOLVED, that the proposed budget of expenditures of the Montauk Union Free School District for the school year 2016-17 in the amount of \$18,978,163 and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education, be and the same hereby is approved and the amount thereof shall be raised by a levy of a tax upon the taxable property of the School District, after first deducting the monies available from State Aid and other sources as provided by Law, with the amount thereof to be raised by a tax levy upon the taxable property of the School District of \$16,952,502.

VOTER QUALIFICATIONS AND INFORMATION FOR BUDGET VOTE MAY 17, 2016

A voter must be:

- 1. 18 years of age
- 2. A U.S. citizen
- 3. A District resident for at least 30 days prior to the vote.
- 4. Registered to vote in the School District

To vote you:

- 1. Do not have to own property.
- 2. Do not have to be a parent or have children.

Proof of Legal Residence is:

- 1. The address on your:
 - (a) Driver's License
 - (b) Federal Income Tax Returns
 - (c) Automobile registration
 - (d) Government registration forms

A Legal Residence is not:

- 1. A temporary address even if you have lived there 30 or more consecutive days before May 17, 2016.
- 2. Related to whether you pay property taxes in the School District.
